The meeting was called to order at 4.00 PM. by the President Shri. A. K. Gandhi.

2. Confirmation of the minutes of the last meeting dated 09.01.2021:

The minutes of the last meetings dated 09.01.2021 were read and signed by the President as approved.

3. To Note Action Taken Report of the last meeting:

The action taken report was read and noted.

4. To Ratify the Resolutions through Circulation:

- (i) Resolution by circulation dated 14.04.2021 regarding Fixed deposits of Rs. 40,00,000/- in the name of Nagpur Shikshan Mandal at HDFC Limited, Civil Lines, Nagpur.
- (ii) The resolution by circulation dated 15.05.2021 regarding to submit proposal for additional section of Junior College to the government on no-grant basis at S. M. M. College of Science.

The above resolutions are ratified.

5. Reports from the Principals and Head Masters:*

(i) Shri. D. D. Nagar Vidyalaya:

Headmistress of the school Mrs. Archana Jainabadkar informed the house that, 1984 students listed on School U-dies from 5th to 12th standard for the session 2020-21 and nearly 900 online forms are also received for the admission in 5th to 8th standard classes for the session 2021-22. She also informed about the 1000 books received on various topics from Nachiket Prakashan and Gramayan Foundation on the basis of cultural activities report submitted by the school. She informed about the various activities organized by the school.

Mrs. Jainabadkar also brought in the notice of the house that, the teachers of the primary unit of the Gurunanak School were joined. Admission of the students for the primary classes were also done for the academic year 2020-21 as per the letter of Education Officer but, Education officer didn't allot U-Dies number till the date for primary unit.

Shri. Anantrao Gharad, Dr. Vibhawari Dani and Adv. Rajeev Deo took part in the discussion and it was decided to make efforts to get U-Dies number for primary unit which was absorbed under 'Samayojan'. President suggested that, a separate

primary unit can be run on no-grant basis if the government denied to allot U-Dies number to the primary unit of Gurunanak School absorbed under 'Samayojan'.

(ii) Ramesh Chandak English School:

Principal of the school Mrs. Aparna Dey informed the house that, the students participated in the various competitions and grabbed the prizes. She also informed that, the staff of the school regularly interact with parents and students regarding the problems faced by them in respect of online classes.

(iii) S. B. City College:

Principal of the college Dr. Sujit Metre informed the house about the various activities organized by the all departments in the college. He brought to the notice of the house that, BCCA department coordinated for executing a MOU with Bajaj Finserv for BFSI certification. He briefed the house about the training programs and workshops organized in the college for students.

(iv) Shri. M. M. College of Science:

Principal of the college Dr. Jeevan Dontulwar informed the house about renovation of computer lab with addition of 35 computers of latest version. He also informed that, the quotation of Gokhale sports for the construction of Basketball ground is approved by Hon'ble President and work will start soon. He briefed the house about the programs organized by the various departments of the college. Principal also brought to the notice that, the proposal for new courses of B.C.A., B.Sc. (I.T), B.Sc. (Microbiology), M.Sc. (Computer Science) and Proposal of additional sections of B.Sc., M.Sc. (Chemistry & Maths) forwarded to the government of Maharashtra by the RTM Nagpur University for approval and college will definitely get approval from govt.

(v) Smt. Binzani Mahila Mahavidyalaya:

Acting Principal of the college Dr. D. S. Shambharkar informed about the activities carried out for the students. He also informed about the proposed online activities for the students and the teachers in the month of June 2021.

Dr. Vibhawari Dani asked about the status of research proposal. Dr. Shambharkar informed that, the grant of research work for the year 2019-20 released to Dr. Amruta Bhuskute and proposals called from the teachers for the year 2020-21 and 2021-22. Dr. Vibhawari Dani informed the house that, she is the member of Research committee but she has not received any communication in this respect from the college. Dr. Shambharkar assured to send report immediately.

6. Any Other Matter:

- (i) President informed the house that, as S. M. M. College of Science applied for the various non-grant UG and PG courses and University forwarded proposal to the government for approval, College is in urgent need of classrooms and for the same we prepared the plan to construct eighteen to twenty new classrooms and the approximate cost of construction will be 2.5 crores to 3 crores. ✓

President also informed that, the proposal to construct eight classrooms at S. B. City College is also submitted to NMC for permission.

Adv. Rajeev Deo and Shri. Mohit Shah suggested to start the construction work as soon as possible.

- (ii) President informed the house that, the ground of S. B. Mahila Mahavidyalaya was used by the outsider for Cricket activity without paying a single penny to NSM but now we prepared the draft of agreement and as per the agreement the club will pay us for ground but total control of the ground will be ours. He also informed the house about starting NSM Sport Academy. In which, our all three VCA affiliated clubs will participate in all VCA tournaments under our banner and for the same we decided that, Dr. Sujit Metre will be the Co-ordinator of NSM Sport Academy.

- (iii) President informed the house that, as decided in the Annual General Meeting, managing committee has to constitute the committee to amend the Constitution of NSM.

Adv. Rajeev Deo suggested to put this matter in physical meeting of managing committee and the matter must be on Agenda. Adv. R. J. Rathi and Shri. Mohit Shah also took part in the discussion. It was decided that, the

committee headed by President Shri. A. K. Gandhi, Adv. R. J. Rathi, Adv. R. S. Deo and Secretary Dr. H. N. Rathi will prepare the draft of amendment.

- (iv) President informed the house that, the auditor of S. M. M. College of Science C.A. Mankeshwar & Co. not responding the college and till now they have not completed the last year accounts of the college so it is mandatory to change the auditors.

It was decided to change the auditor of S. M. M. College of Science after completion of pending work of accounts of last year from C.A. Mankeshwar & Co.



1. To call meeting to Order:

The meeting was called to order at 4.00 PM. by the President Shri. A. K. Gandhi.

2. Confirmation of the minutes of the last meeting.

The minutes of the last meeting dated 26.05.2021 were read and signed by the President as approved.

3. To Note Action Taken Report of the last meeting:

The action taken report was read and noted.

4. To Ratify the Resolutions through Circulation:

Resolutions by circulation dated 12.06.202, 19.06.2021, 09.07.2021, 20.07.2021, 11.08.2021 and 13.08.2021 are ratified.

5. Reports from the Principals and Head Masters:

(i) S. B. City College:

Principal of the college Dr. S. G. Metre informed the house about the various activities and conferences organized by the college. He also informed about the affiliation of various courses received from RTM Nagpur University, Nagpur and the proposal for renewal of Research Center also sent to the University. He briefed the house about the admission position.

(ii) S. B. Mahila Mahavidyalaya:

Officiating Principal of the college Mrs. D. A. Patil brought to the notice of the house that, the very less number of students admitted to classes of B.A. and Junior college. It was decided that, the teachers of the college take extra efforts to increase the number of students in both the courses.

(iii) S. M. M. College of Science:

Principal of the college Dr. J. R. Dontulwar was absent. Committee members showed displeasure on non-submission of college report and non-sending a representative to attend this meeting. It was decided that, the Principal of the college should submit his report within three days.

(iv) Shri. D. D. Nagar Vidyalaya:

Headmistress of the school Mrs. Archana Jainabadkar informed the house that, the issue of the permission of primary school and the salary of the primary teachers is still pending and for the same school has filled a Writ Petition against the Govt. of Maharashtra & Others at Hon'ble High Court Bombay, Nagpur Bench.

(v) Ramesh Chandak English School:

Principal of the school Mrs. Aparna Dey informed the house that, this year also the result of SSC is 100%, this is 15th year of 100% result of the school. House appreciated the efforts of all the staff of the school and congratulated the Principal. She also informed about the various programs conducted online by the school

Adv. Rajeev Deo prepared the development plan for teachers as well as students of K. G. Unit of NSM. He explained his ideas about new K.G. unit. It was discussed in the meeting.

6. To discuss an issue of not handing over the books of accounts and records of the Mandal by Ex-Secretary Shri. Sudhir Baheti:

President informed the house that, Ex-Secretary Shri. Sudhir Baheti yet not handed over the books of accounts and the other records of the Mandal even after the certain reminders. He does not take cognizance to the order of the Deputy Charity Commissioner in application no. 18/2018 filled by us under section 41-A of Public Trust Act. Not only that, he had tried to form illegal managing committee by not obeying the resolution passed by the Mandal and started interference in the working of educational institutions run by Mandal. He had filled court cases against the Mandal and their elected office bearers by making false allegations. Due to such activities of Ex-Secretary Mr. Sudhir Baheti, Mandal has suffered a lot with respect to the smooth conduct of functioning of the Mandal. This conduct considered to be detrimental to the objects of the Mandal. All these detrimental activities of Mr. Baheti resulted in damaging the image of the Mandal in the estimation of the Society. Adv. Rajeev Deo, Shri. M. K. Panpaliya, Shri. Mohit Shah, Shri. C. S. Chandak, Adv. R. J. Rathi and Dr. Vibhawari Dani took part in the

discussion. It was decided to take strict action against Shri. Sudhir Baheti and hence the house passed the following resolution unanimously:

Resolution 01: "Resolved that, considering the conduct of Ex-Secretary Shri. Sudhir Baheti found detrimental to the objects of the Mandal and therefore explanation be called from him before taking a stern action as per the Constitution of NSM."

This was proposed by Adv. Rajeev Deo and seconded by Shri. Mohit Shah. ✓

7. Any Other Matter:

- (i) President informed the house that, the drawings are prepared to construct classrooms at S. M. M. College of Science and S. B. City College. It was decided to start the work as soon as possible.
- (ii) President informed the house that, the change report of the Managing Committee elected on 09.11.2019 is accepted by the Deputy Charity Commissioner, Nagpur. He also informed about the audited statements of five years i.e. from 2015-2016 to 2019-2020 of the Mandal are submitted to the Charity office.
- (iii) The expenditure incurred and paid from 01.04.2021 to 31.08.2021 placed before the house as follows:

Rajendra Rathi informed the house that, the Govt. of India and Hon'ble Supreme Court of India has scheduled to celebrate the program "Bharat ka Amrit Mahotsav" from 2nd October 2021 to 14th November 2021 all over the country at a larger level and all the Institutions run by the Mandal should participate actively in this program. It was decided unanimously that, all the institutions run by the Mandal should participate in the campaign and Adv. Rajendra Rathi, Member of NSM is appointed as Coordinator for this event.
