**MEMORENDUM OF UNDERSTANDING
BETWEEN
TURBO COMPUTER POINT, NAGPUR
AND
SHRI BINZANI CITY COLLEGE, UMRER ROAD, NAGPUR**

This MOU is entered on the 27th Aug day of 2018 by and between **Turbo Computer Point (TCP), Situated at 7, Old Subhedar Layout (Extention), Nagpur. & SHRI BINZANI CITY COLLEGE (SBCT), UMRER ROAD, NAGPUR.**

The aforesaid institutions are hereinafter referred to individually as institute and collectively called as institutes.

1. Objectives of MOU

The objectives of this MOU are:-

- a. To promote and enhance academic interest between TCP and SBCT.
- b. To provide advice for implementation of quality of education at SBCT.
- c. To encourage bright students we are offering IT related Vocational Courses assessment. To promote research / continuing education activities between institutions

2. Benefits of collaborations –

- a. Our Assessment tool has map Current Industrial requirement. This Certification may help the students to career benefits.
- b. Providing Academic Interaction by Delivering Special Lectures by TCP, expert faculties on relevant topics of relevance to modern industry, at extra cost as decided between TCP and SBCT from time to time.
- c. Provide necessary help in Organising Workshop / Seminars and Personality Development Programmes at SBCT for enhancement of Skills of Students.
- d. Usage of academic infrastructure of SBCT to facilitate the students for preparing various Courses.

3. Proposed Mode of Collaboration TCP and SBCT.

Proposed to collaborate through following –

- a. Cooperation and promotion of education and training in the areas of mutual interest.
- b. Any other appropriate mode of interaction agreed upon between TCP and SBCT specific plan can be worked out by the institutes depending upon availability of resources.

A specific agreement can be entered into for each activity.

4. Terms and Conditions:-

- a. The Course will charge by Students.
- b. Share pattern of TCP & College will be 50 – 50 % as per course fees.
- c. The Cost for Examination and any other activity suggested by TCP, will be taken by students

- e. This MOU may be amended, renewed and terminated by mutual written agreement of the institutes at time during sustenance of this MOU.
- f. Either Institute shall have the right to terminate this MOU upon 6 Month's prior written notice to the other institute.
- g. ETH will conduct the Online Examination for Students only after 100% payment receipt with uploading of student data & Completion of Course Duration.
- h. Present Exam Fees Rs. 750/- per student per course including Study Material.
- i. College should ensure to make correct data entry of respective students.
- j. TCP will communicate the Assessment Policy to College on time to time

5. Confidentiality –

- a. TCP, and **SBCT**, agree to hold in confidence all information / data designed by institutes as being confidential which is obtained from either institute or created during the performance of the MOU and will not be disclose the same to any third party without written consent of the other institute.
- b. The above confidential clause under this MOU excludes the information / data possessed by either institute before entering in this MOU or independently developed and / or information already available through public domain.

6. Duration of the MOU


This MOU, unless extended by mutual written consent of the institutes, shall expire in THREE year after the effective date specified in the opening paragraph. However, on review, the MOU shall be extended for another Three year by mutual consent.

7. Coordinators –

Both institutes will designate persons who will have responsibility for co-ordination and implementation of this agreement.

8. Signed in Duplicate –

This MOU is executed in duplicate with each copy being an official version and having equal legal validity. By signing below, the institutes, acting by their duly authorised officers, have caused this Memorandum of Understanding to be executed, effective as of the date and year first above written.

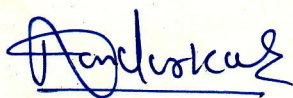
