- ✓ The policy is aimed at promoting the Women's Security Cell activities among students.
- ✓ The policy aims at keeping systematic records of student engagement such that the attainment of various program outcomes (POs) can be measured.

3. **Policy Scope:**

- ✓ The policy applies to girl students of all the years and faculty in-charge of the activities of the cell.
- ✓ It specifies Activity-PO mapping and its attainment.

4. **Step by step process involved:**

- i. The In-charge has to inform the students of the presence of the Women's Cell in the College during Induction Program. She should also highlight the role and activities of the Cell.
- ii. The Incharge has to plan informative programs, training sessions and awareness programs at the beginning of the session. It should be conveyed to all the students and staff in the beginning via circular.
- iii. Before conducting any program, the incharge should issue a notice specifying the time, date, venue and other details of the program was paste the notice at vantage positions in the college.
- iv. The incharge can plan activities involving social activists, advocates, bank executives, corporate trainers or Self Defence trainers to empower girls and give them relevant information regarding their rights and duties.

- vii. A record of all the activities with geo-tagged photographs and newspaper cutting should be maintained by the In-charge.
- viii. The in-charge should prepare in advance the schedule of activities for the semester/year at the beginning of the session and also submit a *semester wise report* to IQAC.

### 5. Terms & Conditions

The in-charge must take efforts in empowering girl students by organizing relevant activities. If the In-charge fails to comply with the duty and responsibility expected of him/her, strict action from the authorities should be taken against them.

### 6. Outcome:

- It is expected that the girl students' personality would be shaped by participating in the training and extension activities.
- The girl students would be empowered by getting information about their rights.

- ✓ Viva Voce or presentation on anyone problem and suggested solution for seniors citizen's problems.
