To create awareness amongst the students about the importance and need of blood in accident cases and surgeries b. To donate blood to the Blood Bank free of cost c. To create a rapport between the Institute and the Blood Bank in case of emergency 3. The Context: The College recognizes the importance of Blood in life threatening situations. There have been cases where people were in immediate requirement of blood and they were unable to find the exact blood group. Many students are unaware of their Blood groups and hemoglobin percentage. They do not know the means to approach the Blood Banks. 4. The Practice: To cater to all of the above mentioned issues, the College has been active in organizing Blood Donation Camps since 12 years. The College has been consistently in collaboration with a renowned Blood Bank named Jeevan Jyoti. Dr Ravi Wankhede of Jeevan Jyoti Blood Bank is also the Secretary of Organ Donation Association of Nagpur. Dr Vibhavari Dani, the Head of the Association, is also a member of Nagpur Shikshan Mandal, the Managing Body. Every year a twin program of Blood Donation and campaigning of the Organ Donation is organized in the College. 5. Evidence of success: Every year around 40 to 50 units of blood are donated to the Bank by the students and teachers of the College. Many teachers, alumni and students have pledged to donate organs. They have formally registered themselves also. The Blood Bank has issued cards

to teachers and students wherein they can get blood as per requirement. This was specially utilized in treating sickle cell patients. 6. Problems encountered and resources required: a. Many students are fearful of Blood donation b. Many girl students are underweight. They also have low hemoglobin count c. There is still ignorance prevalent in society regarding the importance and practice of blood collection BEST PRACTICE II: 1. Title: Visit to Orphanages of mentally disabled children by students 2. Objectives of the practices: a. To create awareness amongst students about mentally disabled children b. To create a platform where the students can reach out to such children and spend some time with them c. To donate gifts and necessary food items amongst such children 3. The Context: The College has organized visits to orphanages in the past. Students are made aware of their responsibility towards society through such activities. But in recent past, the students were taken to differentlyabled (some autistic) children's orphanage. There are many factions of society which need attention and help from the privileged sections. At the same time, there are many students also who have such deprived members in their family. The College felt the need to sensitize the students to give back to society 4. The Practice: To cater to all of the above mentioned issues, the College has been active in organizing visits to Orphanages and Old Age homes. Since a few years, the College has identified two institutions working for differentlyabled children. The students were taken to these Orphanages. They collected money and donated eatables on the occasion of the birthdays of a few students. More importantly, they spent a whole day with those children. A special bond was created amongst them. 5. Evidence of success: Around 10 students visited the Orphanages. They spent a whole day with the children. They interacted with the teachers and care takers. The students got inspired by the experience and decided the go the next year too. They motivated the others also to join them. As a result, this has become a habitual activity for the students. 6. Problems encountered and resources required: a. The students come from middle class society. They are not able to collect enough money or gifts to fulfill the requirement of more number of differentlyabled children. b. Many parents are reluctant to send the students to such orphanages for personal reasons. It is sometimes difficult to convince them. c. At times, the students found it difficult to interact with the differentlyabled children
