Purpose



2. Areas of Cooperation

Subject to the availability of resources and approval of the authorized representatives, both institutions agree to conduct the following collaborative activities:

- Jointly organize UPSC/MPSC workshops, seminars, webinars, symposia, training courses, and conferences on topics of mutual interest.
- Provide basic guidance through the "Basic Learning Foundation Course" for UPSC/MPSC Prelims, Mains, and Interview.
- Provide solution to the problem of the student regarding UPSC/MPSC preparation. To provide basic learning methods to crack the UPSC/MPSC exam.
- Aeon IAS Academy Nagpur will assist S B City College Study Center students to crack the UPSC/MPSC examination.

3. Implementation

All programs or activities implemented under the terms of this Memorandum of Understanding shall be mutually agreed upon. Each of the participating institutions shall be fully responsible for the activities carried out under its direction or by its staff, except as otherwise agreed by the institution. The parties designated **Dr. M. T. Bherwani** as Coordinator from **Late Shri P. V. Narasimha Rao Guidance Center for Competitive Examination & Career Counseling**, Shri Binzani City College and **Mr. Harshadeep Ghuge** as Coordinator from Aeon IAS Academy, Nagpur. They will develop and coordinate specific programs or activities between them.

4. Duration and renewal of agreement

This Memorandum of Understanding will become effective immediately after Signature by the representatives of Shri Binzani City College, Umrer Road, Nagpur and Aeon IAS Academy Nagpur for **a period of 3 years** and is subject to revision or modification by mutual agreement.

5. Amendments

This agreement may, at any time during its period of validity, be terminated by either Institution upon prior notice to the other in writing not later than 3 months before termination date, provided that such termination shall not affect the completion of any program or activity underway at the time the notice of termination is given.

7. Approval

In agreement with the above terms of participation, the authorized representatives of Shri Binzani City College and Aeon IAS Academy Nagpur hereby affix signatures.

Other Terms and Conditions of MOU

Believing that the process of college education can be enriched and academic understanding strengthened, and recognizing the benefits to their respective institutions



from the establishment of academic links and cooperation between the institutions for specific purpose conclude this agreement.

The Linkage document signed on 15-02-2022 by the above THREE institutions is not intended to be a legally binding document. Rather, it is meant to describe the nature and cooperative intentions of those institutions involved and to suggest guidelines for cooperation. The chief objective of the venture is to prepare the students of Semester II and WI for the University Examination by providing them the knowledge and expertise on syllabus of Political Science subject by conducting expert lectures in the form of Faculty Exchange Program using virtual platform. It is expected that the cooperation will have a positive impact on the academic routine of our students. No financial commitment whatsoever, on the part of either signatory to this general document, is intended or implied.

Validity

The Linkage shall remain in force for a period of THREE (3) years from the date of the last signature and will be renewed automatically for periods of the same duration unless it is revoked with the understanding that it may be terminated by the appropriate authorities of either party. The collaborative and clustered activities like faculty exchange, students' exchange, organizing Webinars or seminars, Faculty Development or professional development courses and also skill development or capability enhancement courses can also be undertaken or organized with due permission from the parties entered into this agreement in future also. The entire planning and decision for each activity will be discussed well in advance with each other and with the consent of all, the activities will be planned and organized. The communication and sharing will



be of utmost importance for each institution and on the basis of this agreement it would be a sort of binding on all the parties entering into this linkage agreement.



In order to accomplish this common goal, both SF and SBCC understand that following activities can be undertaken:

- Conduct collaborative seminars, workshops and conferences for students and teachers to sensitize them to issues pertaining to wildlife conservation and environment protection
- Organize field visits for students and teachers to provide hands on practical knowledge of wildlife conservation and environment protection issues
- Undertake projects for students involving field surveys whenever and wherever necessary
- Create opportunities for students of SBCC to volunteer or intern for community based initiatives for wildlife conservation and environment protection within SBCC campus, Nagpur city or field locations where SF is currently operating under the guidance of teachers from SBCC and authorized officials of SF

Reporting and evaluation of activities:

The reporting, evaluation and impact of the activities undertaken as part of this MoU will be carried out under the joint supervision of Executive Director for SF and Principal and Head of the Department (HoD) for the Department of Political Science of SBCC. The resource and material generated as an outcome of the activities carried out as part of this MoU will be property of and accessible to both SF and SBCC. It will be mandatory for both the parties signing this MoU to exchange and give due and equal credit and citation of any resource and material generated as an outcome of the activities carried out as per this MoU.

Funding:

It is understood by both SF and SBCC that this MoU is not a commitment of funds. Any financial impact as part of the activities to be carried out will be decided jointly and SF will not bear any financial impact. Sharing of knowledge and experience will not have any financial impact.

Duration of MoU

Validity

The MoU stands valid for a duration of three year from the day of signing the MoU by both parties and is liable to any further modifications or termination by mutual consent of authorized officials of both the parties signing this MoU.

The MoU is valid for a duration of three year from date of signing and can be renewed with similar terms or modified terms by mutual consent of both parties upon end of validity of the MoU.
